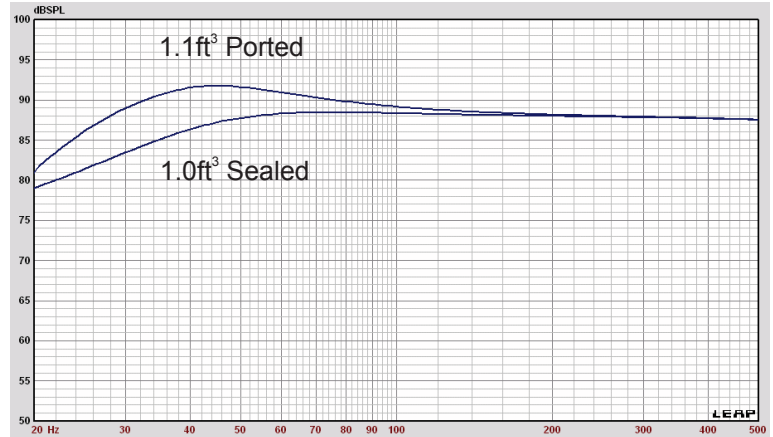

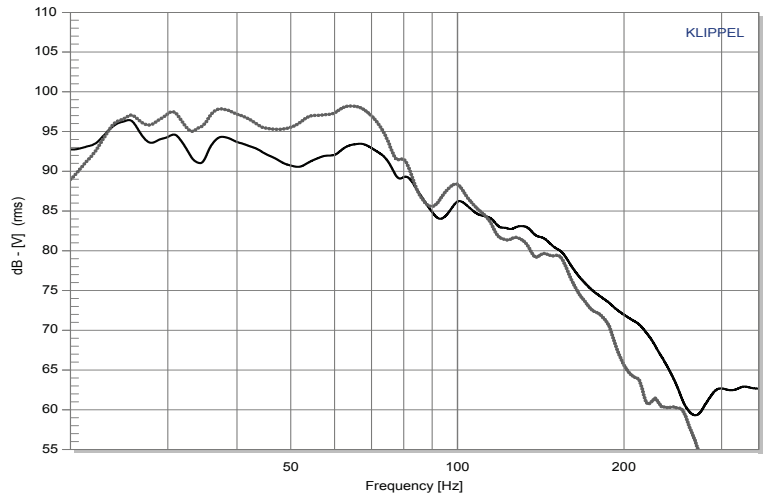

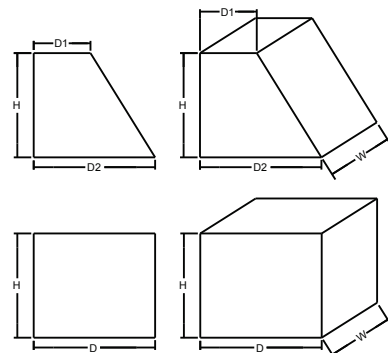
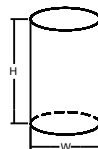
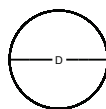


Common Math
